1. The Government of the United Republic of Tanzania has received financing from the African Development Bank towards the cost of the Dar es Salaam Bus Rapid Transit System Project - Phase 2 and intends to apply part of the agreed amount for this loan to cover eligible payments under the Contract for **Provision of Consultancy Service for the Urban Development Support Component of the Dar es Salaam Bus Rapid Transit System Project Phase 2;**
2. The President's Office - Regional Administration and Local Government now invites eligible Consultants to indicate their interest in providing the services of developing appropriate **Institutional Arrangement for Urban Development in Tanzania** and **Transit Oriented Development (TOD) for the Phase II BRT Corridor** from the Central Business District (CBD) to Mbagala Rangi Tatu along Kilwa road;

3. The overall objectives of the assignment are two-fold:
 - a) Developing an Urban Development Strategy and outline Planning Scheme of one selected city/town as a pilot and appropriate institutional arrangement for urban development in Tanzania; and
 - b) Preparing a pilot Transit Oriented Development (TOD) for Phase II BRT Corridor from the **Central Business District (CBD)** to **Mbagala Rangi Tatu** along Kilwa Road and from **Chang'ombe** to **Jitegemee** along Kawawa Road (Kawawa South).

The Consultant is expected to prepare appropriate institutional arrangement, guidelines, General Planning Scheme and Detailed Planning Schemes for three pilot projects for development and operationalization of TOD through an innovative financing approach such as Public-Private-Partnership (PPP) or any other better kind of financing arrangement. However; the estimated duration of the services is twenty four (24) months;

4. The Project Component is being implemented through the President's Office - Regional Administration and Local Government (PO - RALG) in liaison with TANROADS;
5. An interested Consultant must provide information in form of brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc indicating that is qualified to perform the services. Consultants may constitute **Joint -Ventures** to enhance their chances of qualification;
6. A Consultant will be selected in accordance with the African Development Bank's **Rules and Procedures for the use of Consultants** which is available on the Bank's website at <http://www.afdb.org>;
7. Selection will be conducted through the Quality and Cost-Based Selection (QCBS) procedures in accordance with the African Development Bank's **Rules and Procedures fo the use of Consultants**;
