Criteria for evaluation (Commercial)	Any bidder participating in this bidding must have experience as described herein and the evaluation of their offers shall be primarily done on the basis of the following qualifying criteria:  (i) <b>Annual turnover</b> of the tenderer during any one of the preceding 3 (three) financial years (2017-18, 2016-17, 2015-16) shall be at least Rs2.84 Lakh.
		Turnover for this purpose should be as per the audited Balance Sheet of the tenderer. However, if the tenderer is not required to get its accounts audited under section 44AB of the income Tax Act, 1961, a certificate from a Practicing Chartered Accountant towards the turnover of the tenderer along with copy of its Income Tax Return shall be furnished.
