the Bidder to current prices using PSA's consumer price index, if necessary for the purpose of meeting the SLCC requirement;

(ii.8) date of delivery; and

(ii.9) end user's acceptance or official receipt(s) or sales invoice issued for the contract, if completed, which shall be attached to the statements.

(iii) NFCC computation or a committed Line of Credit from a universal or commercial bank.

(iv) If applicable, the Joint Venture Agreement (JVA) in case the joint venture is already in existence, or duly notarized statements from all the potential joint venture partners.

(b) Technical Documents;

(i) The Bid security as to the form of, amount, and validity as follows;

(i.1) a bank draft/guarantee or an irrevocable letter of credit issued by a foreign bank, it shall be accompanied by a confirmation from a Universal or Commercial Bank; or

(i.2) a surety bond, it shall be accompanied by a certification by the Insurance Commission that the surety or insurance company is authorized to issue such instruments;

(ii) Conformity with technical specifications, as enumerated and specified in Sections VI and VII of the Bidding Documents; and

(iii) Omnibus Sworn Statement attesting to the fact that;

(iii.1) It is not blacklisted;

(iii.2) Documents submitted are authentic, complete, and all Information therein is true and correct;

(iii.3) The Head of the Procuring Entity or its duly authorized representative(s) are authorized to verify all documents;

(iii.4) The signatory is duly authorized;

(iii.5) It complies with the disclosure provision under the section 47 of the IRR;

(iii.6) It complies with the responsibilities of a bidder;

(iii.7) It complies with the existing labor laws and standards; and

(iii.8) Non-payment (directly or indirectly) any commission, amount, fee, or any form of consideration in relation to any procurement project or activity;

(iv) For foreign bidders claiming eligibility by reason of their country's extension of reciprocal rights to Filipinos, a certification from the relevant government office of their country stating that Filipinos are allowed to participate in their government procurement activities for the same item or product.

The bid security shall be valid 120 calendar days from the date of opening of bids;
