REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTANCY SERVICES FOR THE **ARCHITECTURAL**, DETAILED ENGINEERING AND CONCEPTUAL DESIGN OF THE NEW MISAMIS OCCIDENTAL PROVINCIAL HOSPITAL (MOPH)

- 1. The Provincial Government of Misamis Occidental through the General Fund 2019 intends to apply the sum of Nine Million, Five Hundred Thousand Pesos Only (P 9,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CONSULTANCY SERVICES FOR THE *ARCHITECTURAL*, DETAILED ENGINEERING AND CONCEPTUAL DESIGN OF THE NEW MISAMIS OCCIDENTAL PROVINCIAL HOSPITAL (MOPH). Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- 2. The Provincial Government of Misamis Occidental now calls for the submission of eligibility documents for CONSULTANCY SERVICES. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before January 14, 2020 at 9:00 in the morning 4th Floor, Provincial Governor's Office, Capitol, Oroquieta City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 3. Interested bidders may obtain further information from the Bids and Awards Committee of the Province of Misamis Occidental and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm Mondays to Fridays.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders on January 9, 2020 to January 28, 2020 9:00 am only to

shortlisted bidder/s upon payment of a non –refundable amount to the cashier (Provincial Treasurer's Office (PTO)of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P 10,000.00 only.

The duration of the submission of proposals as well as the schedule of its opening and evaluation may be shortened depending upon the outcome of the shortlisting.

The Procuring Entity assumes no responsibility whatsoever to compensate or indemnify bidders for any expense incurred in the preparation of the bid.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of a maximum of 3 prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing shall be based on the latest guidelines as provided in the implementing rules and regulations of RA 9184;

OTHER CONDITIONS:

- 1. The Preparation of the Master Plan must be completed within one (1) month from the Contract Preparation and Signing/Implementation/Notice to Proceed.
- 2. Consultant must perform and deliver the required output on *architectural* space planning, interior, landscape and urban design.
- 3. Consultant must deliver engineering services such as but not limited to structural/value engineering, mechanical, electrical, electronics, plumbing/sanitary and fire protection plan/design.
- 4. Consultant must perform Project Management and Consultancy tasks for the project.
- 5. To be included in the shortlist, interested consultant must communicate his/her intent or interest in writing or through e-mail.
- 6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in

the IRR of RA 9184.

- (i) Filipino consultants have sufficient expertise and capability to render the services required under the project: Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 7. The Procuring Entity shall evaluate bids using the Quality Cost Based Selecions (QCBS) procedure:
- 8. The contract shall be completed within a maximum of one (1) month from the date of the Contract Preparation and Signing/Implementation/Notice to Proceed whichever is applicable.
- 9. The Province of Misamis Occidental reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
