The County Mayor, Miami-Dade County (County), pursuant to the Miami-Dade Water and Sewer Department (WASD) Consent Decree and Capital Improvement Programs Acceleration Ordinance Section 2-8.2.12, Sections 2-8.1 and 2-10.4 of the Miami-Dade County Code, Implementing Order 3-34, Administrative Order 3-39, and Florida Statute 287.055, announces that the WASD will require design-build services from one (1) qualified Design-Builder.

The Design Criteria Professional, Brown and Caldwell, and the following subconsultants are not eligible to render design-build services for this solicitation: Avino and Associates Inc; BND Engineers Inc.; Geosol Inc; and Ty Lin International Group. In addition, the Prime Consultant and the following subconsultants from Project No. E13- WASD-01R, Professional Services Agreement Program and Construction Management Services Related to the wastewater system priority projects, are not eligible to render design-build services for this solicitation: AECOM; 300 Engineering Group, PA; Parsons Transportation Group, Inc.; Gannett Fleming, Inc.; and Robayna and Associates, Inc.

The Design-Builder shall provide all resources and professional services to perform the planning, engineering design, permitting, construction, furnishing of all materials, fabrication/installation, labor, and equipment necessary for the construction of all civil/site, process mechanical, architectural, structural, electrical, instrumentation, plumbing, heating, ventilation and air conditioning (HVAC), fire protection, and all other necessary components to facilitate successful design, construction, and commissioning of the new Oxygen Production Facility located at the North District Wastewater Treatment Plant (NDWWTP), 2575 NE 156 Street, North Miami Beach, FL 33160.

Liquidated Damages

This Project is mandated by a Consent Decree and has construction schedule milestones that are critical for completion of this construction Contract. These milestones have either "Contract Liquidated Damages", "Consent Decree Liquidated Damages", or both associated with them.

The duration for the proposed Design-Build contract is 1,320 calendar days, with a total contingency time of 132 calendar days. The total maximum compensation for the Design-Build contract is \$101,528,494.00.
